The Village may forward fees for these services to the applicant for reimbursement, and may delay acceptance of the application, approval of the proposal, or issuance of the permit until such fees are reimbursed by the applicant. Fees forwarded to the applicant that remain unpaid may be included as a special assessment against the property that is the subject of the application or plan.

Costs of mailing notices may be added to all fees.

^{*} The Village may waive the fee for wrecking of buildings subject to condemnation. The Village Chair may waive a public gathering/event license fee.
